You must immediately cease to practice your profession or to perform any act which no person other than a registered person may perform.

Should you continue to practice your profession once you receive this letter, you will be committing a criminal offence and upon conviction, you are liable to a fine not exceeding N\$20,000 or to imprisonment for a period not exceeding five years or the both such fine and such imprisonment.

If you wish to have your name restored to the register, you must complete the attached application form for restoration and pay to Council an amount of N\$ 3,960 in addition to the annual fee of N\$ 2,720. If you are employed, a copy of this letter may be forwarded to your employer.
